Start-Up Kits are typically available immediately. All other orders usually take a minimum of 2-4 weeks to fulfill, so please plan ahead! Each distributor starts as a Regular Distributor with a 20% discount. The more you sell per quarter (3 months) the higher your discount. Distributors are expected to get over \$600 in sales every quarter. Distributors that don't meet this quota will be dropped down to a Junior Distributor. As a Junior Distributor you are required to get at least \$300 in sales per quarter. If you don't reach \$300 your Distributor account will change to an Inactive Status where no discounts are applied until the account is reactivated with a CWC employee. Distributors that go above and beyond can become Gold or Platinum Distributors. If at the end of the quarter you reach \$1200 and \$2000 in sales, respectively, you will move up to the next level. ### AS A CRAFTY WOOD CUTOUTS DISTRIBUTOR I AGREE TO:

1. I will promote and sell Crafty Wood Cutouts, LLC ("Company"), products to Customers by regularly holding craft parties, public, retail or service establishments. I will present Company products in a truthful, sincere and honest manner, and I will conduct myself in a manner that reflects the highest standards of integrity and responsibility in keeping with the reputation of the Company. 2. I will not reproduce any wood designs or crafts from Company. I will not create similar designs or crafts from Company. I will protect the Company's trademarks and trade name by not reproducing the Company's name and/or trademarks or copy any of the Company's materials for use in any advertising without the prior written approval of the Company. 3. As a Distributor, I am an independent contractor and not an agent or employee of the Company. This Agreement does not create an employer/employee relationship, agency, partnership or joint venture between myself and the Company. I cannot act on behalf of, represent or conclude any contracts on behalf of the Company. I do not have any authority to incur any debt, obligation or liability on behalf of the Company. 4. In general, I will not be treated as an employee for federal or state tax purposes. I am responsible for filing all necessary tax returns and reports required by all state and federal taxing authorities (except sales tax), including income and self-employment taxes. The tax laws differ from state to state. 5. I will present the Company's business opportunity in a truthful manner. 6. I will submit product orders to the Company accompanied by full payment by credit card. I understand that all orders are subject to acceptance by the Company. 7. I understand that information and materials provided to me contain confidential and proprietary information of the Company. I will not reproduce any Crafty Wood Cutouts products or make any similar designs. I will not disclose any Crafty Wood Cutouts proprietary information to any other individual or organization. 8. I will not create direct competition against Company that harm sales or reputation of Company. 9. Distributor discount levels and quotas per quarter may not be combined. 10. I will permit the Company to release my name and telephone number in response to a Customer request for a Crafty Wood Cutouts Distributor in my area unless I notify the Company (Crafty Wood Cutouts, 631 N 1200 W, Orem, UT 84057) that I do not want such information released. 11. Due to seasonal and continual change in products. All sales are final. Company will not provide refunds to Distributor on any unused product samples or inventory purchases. 12. Company reserves the right to deactivate a Distributor if, three (3) months of inactivity, or Distributor does not achieve quarterly quotas. Company may terminate this Agreement for breach, or for any reason. 13. This Agreement is subject to acceptance by the Crafty Wood Cutouts home office in Orem, UT, and conditioned upon the receipt of a Distributor Kit. 14. This Agreement cannot be altered, modified or changed through any suggestions, advice, guides or sales aids provided by the Company. It can only be altered, modified or changed in writing issued by an authorized Company representative. 15. This Agreement shall be governed by the laws of Utah as to all matters. 16. All Distributor Kits shipping to Alaska, Hawaii or any U.S. Territory will be charged an additional \$55 and regular shipping and handling fees. This charge must be made to cover the extra costs of shipping outside of the Continental United States.
